CONDITIONS OF PARTICIPATION

The Department of Cultural Affairs is organising the 2nd Monaco Artists' Forum from 5 to 15 June 2014 at the Rainier III Auditorium – an exhibition by Monegasque artists or artists who have lived in the Principality for more than five years. The exhibition will be open to the public every day from 2 p.m. to 7 p.m. Admission is free.

This event is in line with the Prince's Government's wish to promote the inclusion of artists from the Principality in its cultural policy. The aim of the event is to showcase the vitality of local artistic work in the field of the visual arts.

Thus, the format of this event offers every artist the opportunity to have two adjoining panels, each measuring 1 metre long and 2 metres 20 high (i.e. 2 m x 2.20 m in total), on which they can exhibit a pictorial work of their own creation.

For sculptors, a base for the sculpture (50 x 50 x 50 cm) can be provided.

The dimensions of the work must respect the dimensions of the display boards/bases provided. The weight of pictorial works must not exceed 10 kg and sculptures must not weigh more than 80 kg.

Each exhibition area will be equipped with lighting and a nameplate showing the name of the artist and the title of the work.

N.B.:

- details of the stand allocated in the exhibition area will be communicated to participants on the setting-up day;
- transport to and from the exhibition and setting up the work on the exhibition stand will be at the cost of the artists and must be undertaken by them (details of the dates of setting up and removing the work will be communicated later);
- each exhibitor must supply the equipment needed to hang his or her picture (chain and hooks). The use of drawing pins, nails, screws or any materials likely to damage the exhibition display panels is forbidden;
- it will not be possible to plug in any electrical equipment;
- the sale of work during the exhibition is not permitted.

Artists wishing to take part are requested to return the completed application form by post to the Department of Cultural Affairs, 4 Boulevard des Moulins, **before 14 March 2014.** Applicants are reminded that the number of places is limited.
